1.3 CRITERIA WISE SUMMARY

Curricular Aspects

Being a constituent college, it follows the curriculum given by the university. The quality of the academic performance is assured by the IQAC of the college, which gives the utmost effort through constant monitoring and upgradation of the academic standard, scrutiny and analysis of overall results, conducting the innovative teaching process through smart class gadgets as well as usage of ICT in major lab based subjects. Though there is little scope for the teachers to make any alteration in the syllabi, they try to make the learning sessions interesting and interactive, catering to student's queries, projects, seminars, field trips and workshops. Apart from enriching the teaching – learning facilities, these practices also create opportunities to bring the teacher and students together, so that they can work as a team and contribute to the development of the college.

The college offers 19 traditional undergraduate programmes in the faculties of Arts and Science. The courses are offered with subsidized fee structure to serve low income students coming from backward classes. The college also adopted ICT teaching- learning in the different departments. Student enrichment programme are organized at the departmental level.

Teaching-learning and Evaluation

The Teaching - learning and Evaluation describes in brief about process of admission, it deals how these process are monitored and reviewed by the institutional mechanism. It explains how the admission policy of the institute reflects the national commitment to diversity and inclusion. Keeping it in views, institution has adopted a transparent admission procedure with inclusion of a proper weightage to the students of weaker section of the society. It also discusses how the problems of the students are redresses by the redressal cell. It also describes how the IQAC contributed to improve the Teaching and learning process.

This criterion describes in brief the quality of the teachers; most of the teachers are PhD holder and most of them are involved in research activities in the field of guiding the students for PhD project work, publication work and participation in seminar, symposia, workshop and conference at different level.

The college never compromises with qualitative aspect of teaching. Regular planning, which begins well before the teaching programmes. Extra classes are taken for weaker students with adequate students support services, for instance, distribution study materials to students for the purpose of an in-depth and comprehensive study, providing books and other materials to students who cannot afford to buy, and so on. In addition, regular

assessment is carried out through tutorials, mid-term test, and annual tests. The review of the results is always closely scrutinized, and the guardians are informed about the performance of their ward and, if needed, serious warning is also given.

Research, Innovations and Extension

The college encourages and promotes an environment of research and higher studies. Almost all of our faculty members are encourages to be engaged in active research works, be it their individual pursuit of PhD degrees, or Minor Research Projects under UGC. Seminars and workshops are held regularly, and the faculty members have several publications to their credit. Apart from giving them administrative assistance, the college also has a library, which assist the teachers in their personal and professional academic work.

Infrastructure and Learning Resources

The college has recently started developing a state of the art infrastructure to aid and support the student's training and education programme in a tech-savvy and eco-friendly environment. The facilities include well-equipped laboratories, computer centre, Wi-Fi, library, and office automation system. Keeping the evergrowing number of students in mind, which often leads to a space crunch, the college has already constructed spacious rooms. A separate space for library, laboratories, office, common rooms and so on is being put in place.

Student Support and Progression

At the time admission reservation policy of the State Government and University are strictly followed. Free ship is provided to the weaker section of the society. Special classes are arranged for sent up students. Pass percentage during the last four years have been within the range of 90-95% in different department.

The college has placement cell, coaching centre and counselling centre have been playing effective role in motivating and guiding students to better learning and achieving high success rate in their academic career.

Students are involved in various cultural and sports activities. Students of this college represented the university in state level annual Taranga festival organized by different universities of the state and games and sports competitions.

Governance, Leadership and Management

The institution is charged with participatory forum with voices from all tiers of administrative mechanism. The leadership is based on solid platform of democratic participation of advisory support and collective principles. The principal, in association with the IQAC, remains the ultimate go-getter. Performance appraisal of all the faculty members is in balance, which is independently handled by the departments of the college to deliver the best possible output. The principal encourages creativity and innovative ideas and technical schemes, to flourish the entire institution with new strategies, techniques, and planning, so as to build up a model institution in true sense. 1.1 Curricular Planning and Implementation

1.1.1 The Institution ensures effective curriculum delivery through a well planned and documented process

Response:

Teachers are encouraged beforehand to impart the curriculum through innovative teaching methods such as presentations, assignments, discussions, workshops, seminars, industrial visits, computer education apart from internal meetings and develop academic plans for the coming academic year. As per number of working days available, the syllabus is divided into units which are to be finished by a given deadline. Each departments of the college follows the academic calendar issued by the affiliating university. Thereafter, the college plans its annual academic schedule which clearly mentions the topics to be taught and no. of working days allocated to respective topics, the amount of syllabus to be tested in various class, monthly, terminal or half yearly exams.

1.1.2 The institution adheres to the academic calendar including for the conduct of CIE

Response:

Lalit Narayan Mithila University, prepares academic calendar at the outset of the session. During the preparation of this calendar annual leave, activities to be undertaken, resources available etc. are taken into consideration. College calendar is rigid but to some extent, modification is allowed. Teachers conduct Continuous Internal Evaluation (CIE) as per college examination. All departments of our college and students are alert and active in the process of learning. Generally language department like – English arranges workshop on writing skills for effective writing of long answers to attempt long questions. Just after completions of a sub-topic/ topic/ chapter, generally, our teachers assign some task to the students to answer the questions. Teachers asks questions to get feedback so that the discussion of the topic may go in right direction. Again students are allows to ask questions to teachers. Oral tests are held with short questions, objective and summary based questions. In some of the classes, projects are given to the students.

1.3 Curriculum Enrichment

1.3.1 Institution integrates crosscutting issues relevant to Professional Ethics ,Gender, Human Values ,Environment and Sustainability into the Curriculum

Response:

The academic council of the university prepares the curriculum which the college is obliged to implement. However the curriculum incorporates cross cutting issues related to gender, environment, sustainability, human values and professional ethics in its framework. In subjects like Botany and chemistry the issues related to environment and pollution are incorporated. Similarly economics incorporates the issues of sustainable development. The question of values and gender are dealt within the syllabi of literature and philosophy.

Many of students are from minority community. Hence all possible measures are taken to educate staff and students on issues of holistic inclusion. This is done through planned gender/comunal sensitization pogrammes. Gender sensitization issues are highlighted through display of posters. The women safety tips are revealed by organizing programmes like women's Day celebration, discussions and debates under Political Science department of the college. Seminar on human rights and women rights are organized frequently to create awareness among the students on these issues. Education on environment and awareness on climate change is provided in class and through awareness campaigns. Importance of water conservation is stressed through rainwater harvesting and minimal use of available water. 2.2 Catering to Student Diversity

2.2.1 The institution assesses the learning levels of the students and organises special Programmes for advanced learners and slow learners

Response:

Teaching the slow learners and the weaker students is a challenging task. However the slow learners should be treated same as the normal students. Some techniques need to be applied for these students. Some such techniques applied in our college are as follows:

On the basis of their performance in class based assessment, the slow learners are identified. These learners are given more time in explaining the difficult concepts. They are explained various concepts by different examples.

Slow learners are taught in small groups so that they can understand things property as the teachers come in close with them. They need extra attention of the teachers which they are able to receive in small groups.

The performance of such students is regularly reviewed and on the basis of feedback new strategy is adopted to teach them. The regular review helps in the improvement of the performance of the learners.

For Advanced learners the teachers apply a different method. They prescribe them books & related websites for further reading. They are suggested to use library and internet for further enhancement of their learning. They also get opportunity to ask questions to teachers and meet them for any doubt clearance and further discussion. Faculty members monitor progress of the students on regular basis via class tests, presentation, group discussions, etc. The data collected on these bases is analyzed and accordingly corrective measures are done on continuous basis in lectures/ tutorials/ practicals. All the departments in their regular meetings do collectively review the progress of the courses and the possible problems faced by the students.

Students are also encouraged to use the library independently that enhances their knowledge. NRC (Network Resource Centre) and Wi-Fi facility in college campus provides easy access Io internet for latest information. The conventional lecture method has been modified by dividing one lecture session in two part. First part will be of lecture of teacher on the topic and the second part will be of lecture-cum-question-answer in which both components should have equal time frame. Thus, tilts shifts from monologue to dialogue has led to

increase interest of the students in to the classroom, classroom seminars, debate and discussions. Smart class is also used to demonstrate ICT based learning materials which adds differen flavour to the learning of the students.

Assessment methodology/tolls are decided keeping in mind the parameters/learning outcomes to be measured and desired emphasis.

The college has a systematic process of collecting and evaluation data on programme and course learning outcomes and uses it to overcome the barriers to learning. The process of course outcome assessment is based on mid examination, semester and examination, assignment and quiz. Each question in mid/semester end/assignment/quiz are tagged to the corresponding and the overall attainment of that is based on average mark is set as target for final attainment. The following processes & tolls for the attainment of course outcomes.

The college follows a process of teaching that urges the teachers to design, deliver and assess. Upon receiving the syllabus from the university, the teachers design the curriculum in a way best suited for the students. They then follow a variety of teaching methods to successfully deliver the said curriculum to the students in ay that they can understand the same. After delivering the syllabus, the teachers conduct examinations to asses this understanding. Based on their individual analysis of every student, the ones who seem to required more attention than others are offered remedial classes to help with their academic performance.

This process of providing additional support to the ones comes under the program of plan, do check and act similar to design, deliver and assess program specific and course outcomes are arrived at after above mentioned steps are taken. After strict adherences to above procedures the college can provide outcomes.

6.4.3 Institutional strategies for mobilisation of funds and the optimal utilisation of resources
